## SECTION 4 - FIRST AID MEASURES

<b>Inhalation</b>	IF INHALED: Remove person to fresh air and keep comfortable for breathing. Immediately call a doctor.
<b>Ingestion</b>	IF SWALLOWED: Rinse mouth. Do NOT induce vomiting. NEVER give anything by mouth if victim is rapidly losing consciousness, or is unconscious or convulsing. <b>Suitable and unsuitable extinguishing media</b>	In case of fire: Use carbon dioxide, chemical powder agent and appropriate foam to extinguish.
<b>Special protective equipment and precautions for fire-fighters</b>	During a fire, irritating/toxic smoke and fumes may be generated. Do not enter fire area without proper protection. <b>Personal precautions, protective equipment and emergency procedures</b>	Absorb spillage to prevent material-damage. Restrict access to area until completion of clean-up. <b>Precautions for safe handling</b>	Wear protective gloves/ protective clothing/ eye protection/ face protection. Before handling, it is very important that engineering controls are operating, and that protective equipment requirements and personal hygiene measures are being followed. People working with this chemical should be properly trained regarding its hazards and its safe use. Inspect containers for leaks before handling. Label containers appropriately. Ensure proper ventilation. Avoid breathing dust/fume/gas/mist/vapours/spray. Avoid contact with eyes, skin and clothing. Keep away from heat, sparks and flame. Store away from incompatible materials (Section 10). Inspect all incoming containers to make sure they are properly labelled and not damaged. Storage area should be clearly identified, clear of obstruction and accessible only to trained personnel. Inspect periodically for damage or leaks.
